High Growth Potential

Global data center investments are expected to increase from \$321bn in 2022 to \$410bn in 2025 to support the growth of 5G, smart grids, and other forms of tech-based infrastructure.⁽¹⁾

The shift to 5G-enabled devices is well underway. 5G subscriptions worldwide are expected to surpass 1.5bn in 2023 and over 3.5bn by 2026. ⁽²⁾ Accelerated development of digital infrastructure is necessary to support this growth.




SECTOR BREAKDOWN (%)
