pays a fixed interest rate and receives a floating interest rate. The Fund is expected to benefit from the options it holds if long-term U.S. interest rates rise during the time period in which the Fund holds the options. However, if long-term rates decrease, the Fund will lose money on the options, up to the amount invested in option premiums, and underperform an otherwise identical bond fund that had not used such options. Options may subject the Funds to greater volatility than investments in traditional securities and may magnify the Funds' gains or losses. Over-the-counter options are traded directly between counterparties rather than on a centralized exchange.
