




NEWS AND WHAT TO LOOK FOR


- Marathon Petroleum Corp. (MPC) dropped down just over \$2 billion in assets to its MLP, MPLX. \$504m in MPLX equity issued to MPC and \$1.5bn in cash from recent debt offerings will finance this dropdown. (Source: MPLX)
- Enbridge Inc. (ENB) completed their previously announced merger with Spectra Energy Corp (SE). Through this transaction, Spectra Energy's common stock will be delisted and deregistered. The common shares of Enbridge will continue to trade under the same ticker. (Source: Enbridge)
- Tesoro agreed to waive \$100 million of general partner IDR payments over 2017 and 2018 in an effort to open up further growth opportunities for Tesoro's limited partner, Tesoro Logistics, L.P. (Source: GlobeNewswire)

CURRENT YIELD COMPARISON¹





ENTERPRISE VALUE TO EBITDA VALUATIONS (5-Years)¹





SPREAD TO 10-YEAR US TREASURIES¹ (since 4/30/12)





As of 02/28/2017, Marathon Petroleum was a holding in the Global X S&P 500 Catholic Values ETF (CATH), with a 0.13% weighting and the Global X Scientific Beta US ETF (SCIU), with a 0.12% weighting. MPLX LP was a holding in the Global X MLP and Energy Infrastructure ETF (MLPX), with a 1.46% weighting and the Global X MLP ETF (MLPA), with a 6.14% weighting. Enbridge Inc was a holding in the MLPX ETF, with a 16.60% weighting and the SCIU ETF with 0.01% weighting. Tesoro Corp was a holding in the CATH ETF with a 0.05% weighting and the SCIU ETF with 0.22% weighting. Tesoro Logistics LP was a holding in the MLPX ETF with a 0.59% weighting and the MLPA ETF with a 3.35% weighting.

DEFINITIONS

Solactive MLP Infrastructure Index: The Solactive MLP Infrastructure Index is intended to give investors a means of tracking the performance of the energy infrastructure MLP asset class in the United States. The index is composed of Midstream MLPs engaged in the transportation, storage, and processing of natural resources.

Bloomberg Barclays US Corporate High Yield Index: The Bloomberg Barclays US Corporate High Yield Bond Index measures the USD-denominated, high yield, fixed-rate corporate bond market. Securities are classified as high yield if the middle rating of Moody's, Fitch and S&P is Ba1/BB+/BB+ or below. Bonds from issuers with an emerging markets country of risk, based on Barclays EM country definition, are excluded.

BofA Merrill Lynch Fixed Rate Preferred Securities Index: BofA Merrill Lynch Fixed Rate Preferred Securities Index tracks the performance of fixed-rate U.S. dollar-denominated preferred securities issued in the U.S. domestic market.

J.P. Morgan EMBI Global Core Index: J.P. Morgan EMBI Global Core Index is a broad, diverse U.S. dollar-denominated emerging markets debt benchmark that tracks the total return of actively traded external debt instruments in emerging market countries.

FTSE NAREIT Composite index: The FTSE NAREIT Composite REIT Index is a free-float adjusted, market capitalization-weighted index of U.S. Equity and Mortgage REITs. Constituents of the Index include all tax-qualified REITs that also meet FTSE's minimum size and liquidity criteria.

iBoxx USD Liquid Investment Grade Index: The iBoxx USD Liquid Investment Grade index measures the performance of 600 highly liquid investment grade corporate bonds.

S&P 500 Index: S&P 500 Index tracks the performance of 500 leading U.S. stocks and captures approximately 80% coverage of available U.S. market capitalization. It is widely regarded as the best single gauge of large-cap U.S. equities.

S&P 500 Energy Index: The S&P 500[®] Energy Index comprises those companies included in the S&P 500 that are classified as members of the GICS[®] energy sector.

CBOE 10 Year Treasury Note Yield Index: The CBOE 10-Year Treasury Note is based on 10 times the yield-to-maturity on the most recently auctioned 10-year Treasury note.

Utilities Select Sector Index: The Utilities Select Sector Index seeks to provide an effective representation of the utilities sector of the S&P 500 Index. The Index includes companies from the following industries: electric utilities; water utilities; multi-utilities; independent power producers and energy traders; and gas utilities.

Crude Oil: Measured based on the Generic 1st 'CL' Future, which is the nearest crude oil future to expiration.

Natural Gas: Measured based on the Generic 1st 'NG' Future, which is the nearest Natural gas future to expiration.

Correlation: Correlation is a measure that shows how two securities move in relation to each other. A correlation of 1 implies that the securities will exhibit the same price movements. A correlation of 0 means the securities demonstrate completely unrelated price movements.

EBITDA: Earnings before interest, tax, depreciation and amortization (EBITDA) is a measure of a company's operating performance. Essentially, it's a way to evaluate a company's performance without having to factor in financing decisions, accounting decisions or tax environments.

Average Spread: Average spread is the average of the excess of the MLPs yield over the 10 year treasuries yield.

Enterprise Value (EV): EV is a measure of a company's total value, often used as a more comprehensive alternative to equity market capitalization. Enterprise value can be thought of as the theoretical takeover price if the company were to be bought.

The fund is taxed as a regular corporation for federal income tax purposes, which differs from most investment companies. Due to its investment in MLPs, the fund will be obligated to pay applicable federal and state corporate income taxes on its taxable income as opposed to most other investment companies. The fund expects that a portion of the distributions it receives from MLPs may be treated as tax-deferred return of capital. The amount of taxes currently paid by the fund will vary depending on the amount of income and gains derived from MLP interests and such taxes will reduce an investor's return from an investment in the fund. The fund will accrue deferred income taxes for any future tax liability associated with certain MLP interests. Upon the sale of an MLP security, the fund may be liable for previously deferred taxes which may increase expenses and lower the fund's NAV. The potential tax benefits from investing in MLPs depend on them being treated as partnerships for federal income tax purposes. If the MLP is deemed to be a corporation then its income would be subject to federal taxation at the entity level, reducing the amount of cash available for distribution to the fund which could result in a reduction of the fund's value. The index however is calculated without any deductions for taxes. As a result, the Fund's after tax performance could differ significantly from the index even if the pretax performance of the Fund and the performance of the index are closely correlated.
